# 3. Treasurer - Katarina Mansir: Budget to date

Katarina shares the financial overview for February 2024.

Total: \$235,705.97

Deposits in the amount of \$9,690.83 include Level Up, 5th grade pledge drive parent donations, corporate matches, Spirit Gear/online apparel profits, Family Art Night donations and 5th grade fundraiser profits.

Expenses in the amount of \$21,155.50 include reading subscriptions, grade level grants and classroom reimbursements.

## 4. Principal - Dusty Pedrotti

Mr. Pedrotti begins by giving thanks and sharing his gratitude for the FFC and the funds raised so that our students get to do more.

We have had a few new students start, and the choice application process is complete and new families were able to take a tour of the school.

Mr. Pedrotti shares the bad news that the District is in a serious deficit and bit of a mess, so pink slips will be going out. This may affect some of our teachers, so feel free to reach out to him if you have any questions.

On a brighter note, Mr. Pedrotti was happy to be able to pop into BizTown with the 5th graders for a visit and see what a great experience they were having. He was also happy to go on the field trip to Marshall Middle School and even got to see some of his past students.

#### 5. Staff - Mr. Joe Marsella, Ms. Boelzle, Ms. Becker

Nothing new to report. Cathryn thanks all of them for their time and effort helping with the Staff Experience raffle.

#### V. Committee Reports

#### 1. EAR

We are continuing to work on things and are trying to put together another EAR coffee chat. Also working on admin tasks to see when we want to conclude the reading for the year and hold the end-of-year ceremony. We haven't discussed another training date, but if anyone still wants to volunteer, we will always take you and will figure out the training.

#### 2. Art Corps - Art Show

Sandra is happy to announce that the Art Show posters were printed yesterday. She inquires if it is okay to put them up, and Mr. Pedrotti confirms it is fine for her to put them up. They are still discussing food/refreshment options for the night and are considering food trucks, a cotton candy machine or having the 5th grade committee come in a sell pizza, snacks and drinks.

Mrs. Becker adds that she could try to organize and coordinate having some of the 5th graders help sell stuff to raise money for the 5th grade promotion.

Amber adds that the 5th grade committee is actually in a good place with funds raised, so we don't really need to fundraise anymore.

It is agreed that we can discuss at a later time to finalize the plan for food/refreshments at the Art Show.

Sandra adds that she needs the teachers to sign-up for time-slots to view the artwork in the MPR and is still working on getting enough docents to take the classes around. She is trying to get more parent volunteers. Lisa confirms that we

usually end up with a lot of people to help. Mr. Pedrotti adds that if we end up with a few classes without a docent, please let him know.

# 3. STEAM - Math Olympiad Noetic Math Update, 3D printer update

Karthika starts by thanking Mr. Pedrotti for taking on Math Olympiad. The final competition is March 14. The Noetic Math official test date is April 17. Karthika is looking into options for coaching.

Kelly and Greg report that STEAM challenges for 1st and 2nd grade are set up and available in the MakerSpace. They will work on getting challenges set up for Kindergarten.

The 3D printers are getting set up and calibrated. There has been a lot of interest so they are working on a schedule and brainstorming how to use them and get them into the classrooms.
